Despite the difficulties caused by the CoViD-19 pandemic, all the planned teaching activities were offered to the Module participants, and the students had the opportunity to attend remotely the following Jean Monnet courses: “*Solidarity in European Union Law: Mapping the Field*”, lectured by **Prof. Leonardo Pasquali** (Professor of EU Law at the University of Pisa and Academic Coordinator of our Jean Monnet Module); “*Environment Protection and Solidarity in EU Law*”, lectured by **Prof. Estelle Brosset** (Professor of Public Law at Aix-Marseille University and Key Staff Member of our Jean Monnet Module); “*Solidarity and Migrations in Latin America: the Case of Brazil*”, lectured by **Prof. Tarin Cristino Frota Mont’Alverne** (Professor of International Private Law, National Migration Policy, Law of the Sea, International Environmental Protection and Integration Law at the Faculty of Law of the Federal University of Ceará, Brazil); “*Right to Health and Solidarity in EU Law*”, lectured by **Prof. Pietro Milazzo** (Professor of Constitutional Law at the University of Pisa and Key Staff Member of our Jean Monnet Module); “*Human Rights and Solidarity in EU Law*”, lectured by **Prof. Francesca Martines** (Professor of International Law at the University of Pisa and Key Staff Member of our Jean Monnet Module); “*Social Rights and Solidarity in Europe*”, lectured by **Prof. Elisabetta Catelani** (Professor of Public Law at the University of Pisa and Key Staff Member of our Jean Monnet Module); “*Solidarity in European Union External Action (Investment Agreements)*”, lectured by **Prof. Francisco-Pascual Vives** (Professor of International Law and International Relations at the University of Alcalà, Spain, and Key Staff Member of our Jean Monnet Module); “*EU Citizenship and Solidarity*”, lectured by **Prof. Leonardo Pasquali**; “*Terrorism and Solidarity in EU Law*”, lectured by **Dr. Matteo Del Chicca** (Lecturer of EU Law at the University of Pisa and Key Staff Member of our Jean Monnet Module); and “*Natural or Man-made Disaster and Solidarity in EU law*”, lectured by **Prof. Teresa Russo** (Professor of EU Law and EU Migration Law at the University of Salerno and Key Staff Member of our Jean Monnet Module).

Moreover, many other activities were performed during the year. For example, on Thursday 10 December 2020, a “**SoEULaw**” **Workshop** took place remotely: in such framework, the **e-book** “*New Awareness of Solidarity in EU Law and Beyond*”, edited by **Dr. Matteo Del Chicca** and

collecting the best papers written so far by the participants to the Jean Monnet Module activities, was presented, and the discussion about Solidarity went on. On Thursday 10 December 2020, also the **Roundtable “CoViD-19 and Solidarity Beyond Law”** took place remotely: it was the occasion to discuss Solidarity also beyond the perspective of Law, thanks to the participation of prominent experts and stakeholders from several other disciplines.

All the activities were promoted in order to reach a wide interest, attract different target groups and increase their knowledge in specific European Union studies related to Solidarity. The second year of the Module also increased the interest in Solidarity as a research field for the development of academic works and, thanks to the participation of leading professors from Italy, Spain, France and Latin America, it contributed to the creation of a European and international network on Solidarity.
